Express voluntary assumption of risk. I voluntarily accept all risks necessarily flowing from my participation which could result in loss of life or injury.

Liability release and indemnity I hereby release Ruckus Scooters and all persons or corporations associated directly or indirectly with these activities from all claims, demands or proceedings arising from my participation and hereby indemnify them from all liability (including liability for their negligence and the negligence of others) for all injury, loss or damage arising out of or connecting with my participation in these activities.
